ANNUAL MEETING

The annual meeting was held on Saturday, January 17, 2016, at the Weston Steakhouse. members were present and thanks to those members who took time to participate in the meeting. A special "at-a-boy" to Chris Johnson who drove all that way to be there.

Minutes of the meeting are available elsewhere in this newsletter. However, I will attempt to summarize some key issues. The slate of officers were elected by acclamation as there were no contested races in the WVRA administrative offices. Jim Barnes was the only new officer elected, replacing treasurer Tim Glaser who has moved to North Carolina. The full slate of officers for 2016 can be seen in the list of officers shown elsewhere in the Trans-Allegheny Dispatch.

Vote!

The Beverly Heritage Days event passed muster at the January 16 meeting and has now moved on to the 'Full Ballot Procedure' listed in the by-laws under Section 5 – Sanctioned Events. Before I go any further, some members have questioned me on what is a 'Sactioned Event.'

According to our by-laws: "Sanctioned Events are those not planned or organized by the WVRA, but approved by the Association for official participation. Attendance at sanctioned events is expected of all WVRA members." Note -The rest of that by-law can be found at WVRA.org.

Beverly Heritage Days - Centuries of History are scheduled for July 22 through July 24 at Beverly, W. Va. This event will be a "timeline" featuring living history and other programming from periods throughout Beverly's history. By timeline, the intent is to allow living history from multiple time periods. Preliminary planning shows living historians from the pioneer and Native American, Civil War and World War II periods. However, other periods may be represented.

WVRA members must now vote by February 26 to sanction or not sanction this event. Please see the ballot included with this newsletter. Mark Tennant has agreed to be the Civil War era coordinator.
